The Antigua and Barbuda Citizenship by Investment (CIP) Act was passed in April, 2013. The Citizenship by Investment Unit (CIU), a creature of the legislation, was staffed on August 26, 2013 and opened to the public on October 10, 2013. The first application was received in November 2013. The first citizenship was granted in February of 2014.

Managed by a dedicated team of professionals, the CIU is the authority responsible for processing all applications submitted for Citizenship by Investment, issuing all Agent Licenses, as well as approving Authorized Representatives, Projects and Business Investments. The ultimate responsibility of the Program rests with the Office of the Prime Minister.

The Unit is proud to be a Corporate Member of the Investment Migration Council (IMC), the worldwide association for the Investor Migration and Citizenship-by-Investment industry. The IMC sets the standards acting as a regulator on a global level and interacts with other professional associations, governments and international organizations in relation to investment migration.

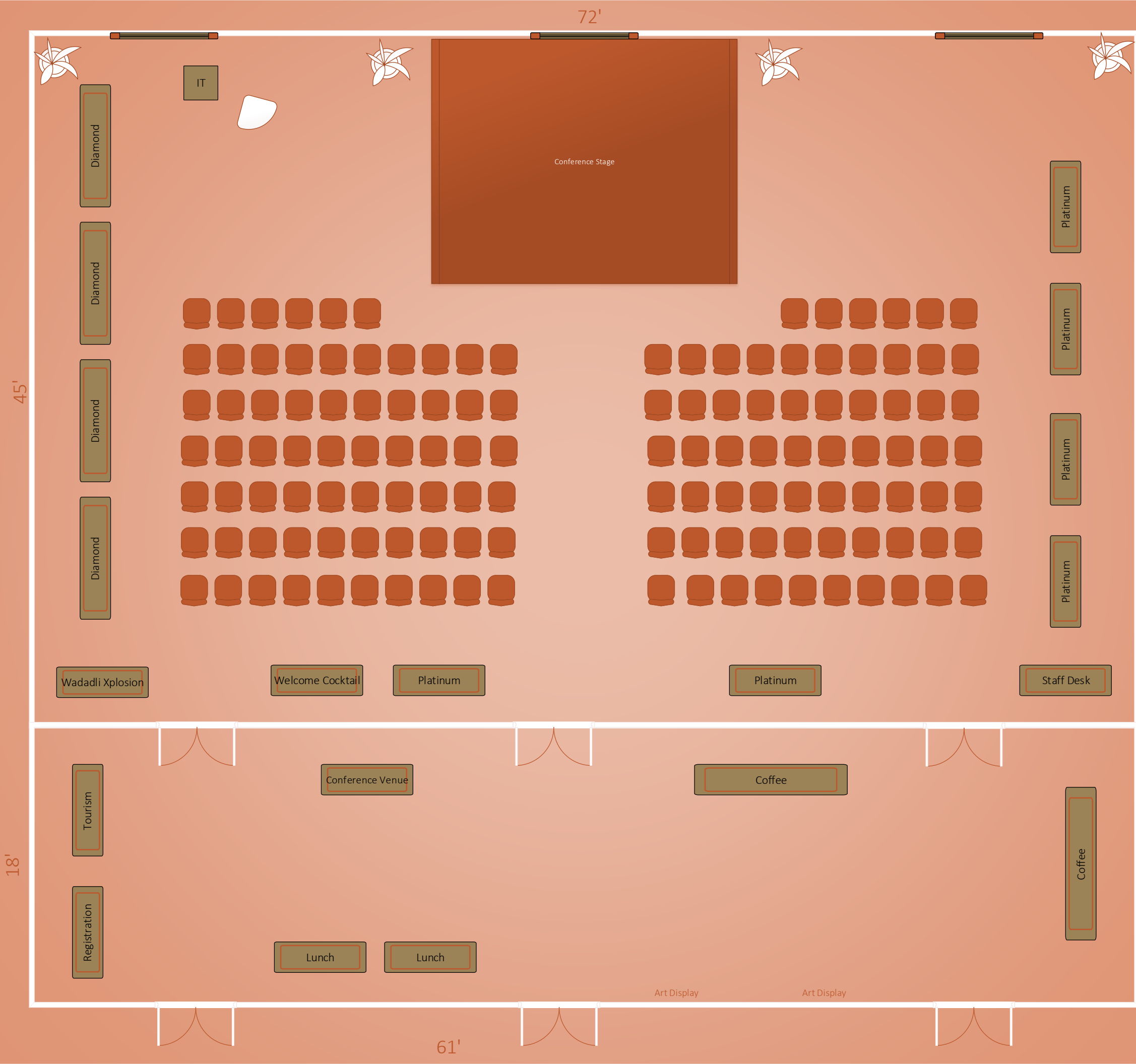
