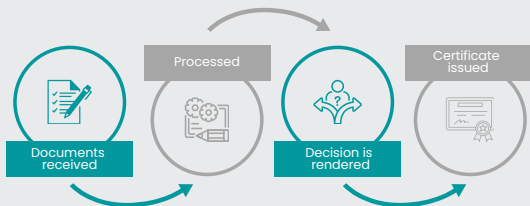
What is An Authorized Representative

Authorized Representative Procedure and Requirements



- A Certified copy of Certificate of Incorporation (or other appropriate certificate of registration or licensing)
- A Certified copy of Memorandum and Articles of Association
- Certified Copies of AML/KYC policies
- All of the Antigua & Barbuda Citizenship by Investment Program promotional information that will be publicly disseminated. This should be provided in English and an English version should also be accessible on their website once approval is granted
- A Character Reference Letter or Reference Letter written by an independent individual, associated body or corporation
- A Certified copy of the company's Share Certificate
- Certified copies of ID documents for Owners, Directors and Executive Management
- Proof of Business address
- Processing fee of US\$5000.00
