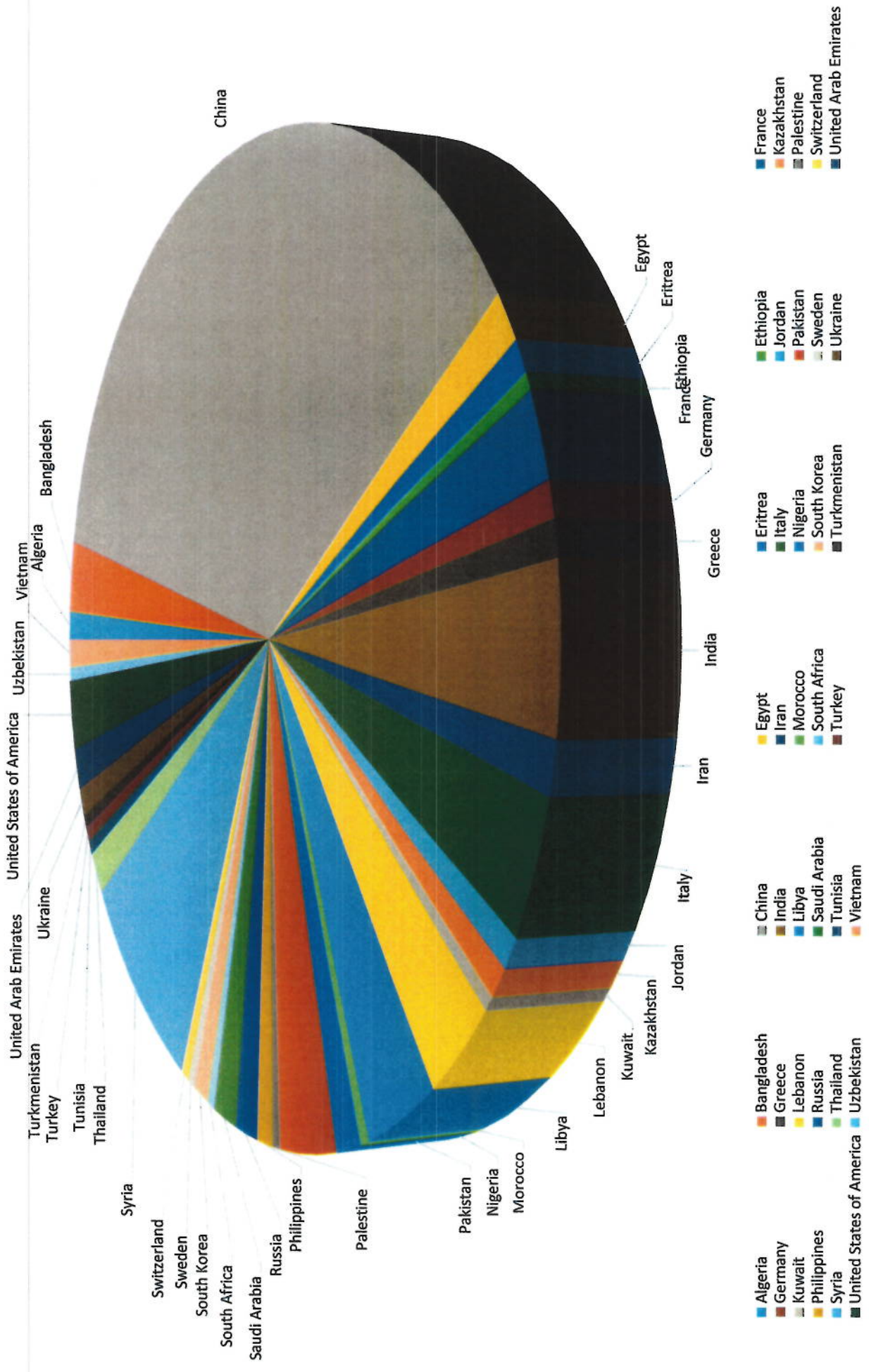

CIP Applications 1st June 2015 to 16th December 2015



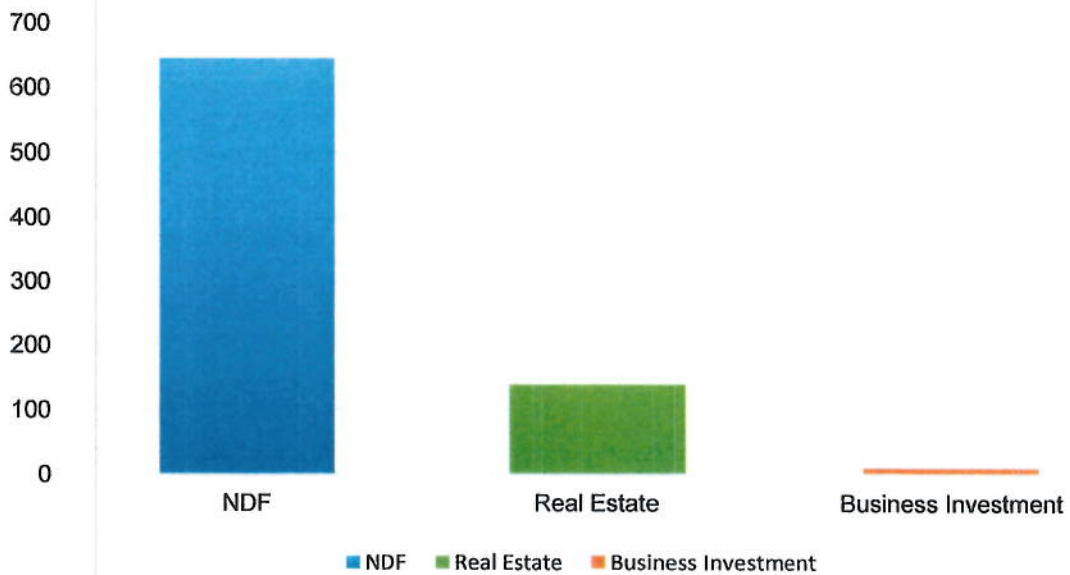
